**RIDE CAMP:** Ride camp will be held at the beautiful, historic Meadowbrook Ranch, owned by the Vandegrift family (Back in the 90s, a member of the Vandegrift family completed TEVIS --- see Cougar Rock pictures in the Red Barn, where management will be). The address to ride camp is **15424 Skyway Rd, Magalia, CA 95954**. Trailer parking will be picturesque, with some shady spots, but a bit spread out; first come first serve for the best spots. There is plenty of natural water in camp – you can even swim with your horse if you like! Camping fee is \$30 per rig for the weekend (Friday-Monday), so please trailer-pool & split the camping cost. You will pay the camping fee when you pick up your rider packet at the Red Barn. Dogs are welcome, please make sure they are well-mannered & behaved at all times, and of course, no dogs on the trail course.

**AWARDS:** Completion awards only. Sunday's ride is a no-frills ride; however, we may throw in a few fun awards for those who stick around Sunday evening --- We just might have some leftover prizes from Saturday.

**TRAIL:** Magalia is located just above Paradise, in the mountains above Chico. We have stunning views, tree lined trails, natural water sources -- plenty of "Kodak moments" waiting for you (and photographer Lisa Chadwick to capture some of them). There will be lots of logging road and some gravel road, but also some single-track. In October, it could be hot or it could be cool, so come prepared for either. There will be shade & water on the trail & spotters at road crossings. The footing is pretty good, but there are some rocky sections, so please come shod or with boots. \*Sunday's trail will be different from Saturday's\* (just a tad easier, too)

**THE CAUSE:** This ride is in memory of a fine young equestrian who aspired to help and heal others. The profit from Saturday's ride will go to the Kristina Chesterman Memorial Clinic in Nigeria. However, on Sunday, we are deeming this a "pay-it-forward" day in honor of Kristina! It was not uncommon for her to pay for a stranger's coffee or brighten someone's day with a smile and a few kind words. We have decided to pick a member of our endurance family (out of submissions entered this year) to give whatever profit we make on Sunday --- to help with an unexpected bill, or maybe just to brighten a day!

#### **DIRECTIONS:**

From the **5N**: Take 99N towards Yuba City/Marysville, then merge onto the 70 towards Marysville. Follow signs through Marysville to continue following the 70 towards Oroville/Paradise/Quincy. From the 70, turn left at the 191/Clark Road towards Paradise. Take Clark until it dead ends at Skyway (approximately 15 miles), make a slight right at Skyway and continue up Skyway for several miles, crossing the bridge and passing through downtown Magalia. You will see Meadowbrook Ranch on your right.

From the **5S**: Take the CA-36/CA-99/Antelope Blvd exit towards Red Bluff/Chico. Follow the 99S towards Chico for approximately 40 miles, then take the Skyway exit towards Paradise

(turning left). Follow Skyway through the town of Paradise and then over the bridge into Magalia, proceeding to Meadowbrook Ranch, which will be on the right hand side.

I am aware that participating in these events involves the risk of injury to my person and property, involves being in remote areas for extended periods of time, far from communications, transportation, medical facilities; that these areas have many natural and manmade hazards which ride management cannot anticipate, identify, modify, or eliminate, that accidents can happen to anyone at any time. I voluntarily accept all risk of personal injury (including death), and property damage arising from my attendance and participation in these events. As lawful consideration for being permitted to participate in these events, I hereby agree that I, my heirs, personal representatives, and assigns will not make a claim against or sue the Kristina Chesterman Memorial Ride, its employees, officers, directors, members, agents, or affiliated entities for any injury or damage arising from the negligence of other acts, however caused, of the Kristina Chesterman Memorial Ride, its employees, ride veterinarians, officers, directors, members, agents, contractors, members, employees, agents, contractors, guests, invitees, and affiliated entities from all actions, claims or demands, that from my participating in the Kristina Chesterman Memorial Ride. I agree that this release includes injury or damaged caused in whole or in part by negligence, active or passive, of the Kristina Chesterman Memorial Ride and its members, employees, ride veterinarians, landowners, agents, and contracting parties. All juniors under the age of 16 must be sponsored and stay with their sponsors due to insurance and the hazardous nature of the trail. I have carefully read this agreement.
