RIDE CAMP: Ride camp will be held at the beautiful, historic Meadowbrook Ranch, owned by the Vandegrift family (Back in the 90s, a member of the Vandegrift family completed TEVIS --- see Cougar Rock pictures in the Red Barn, where management will be). The address to ride camp is **15424 Skyway Rd, Magalia, CA 95954**. Trailer parking will be picturesque, with some shady spots, but a bit spread out; first come first serve for the best spots. Parking crew will be available to help on Friday from late-morning to late-afternoon only. There is plenty of natural water in camp – you can even swim with your horse if you like! Camping fee is \$20 per rig, so please trailer-pool & split the camping cost. You will pay the camping fee when you pick up your rider packet at the Red Barn. Dogs are welcome, but please make sure they are on leash and under control at all times, and of course, no dogs on the trail course.

AWARDS: TO FINISH IS TO WIN, so everyone completing the ride will receive a completion award. We will also have a participation award for every entered rider. There will also be Top Ten awards for the 35/50 mile riders. We will have a Best Condition award, chosen by the vets, for the 35/50 mile rides. There will also be first junior awards in all distances. Awards will be handed out post-ride. No awards will be mailed. There will be no ties.

TRAIL: Magalia is located just above Paradise, in the mountains above Chico. We have stunning views, tree lined trails, natural water sources -- plenty of "Kodak moments" waiting for you (and a photographer to capture some of them). There will be lots of logging road and some gravel road, but also some single-track. There will be shade & water on the trail & spotters at road crossings. The footing can be pretty good in some spots, but there are some rocky sections, so please come shod or with boots. The weather should be mild. Vet checks are out of camp, and once again, we will have rider drinks and snacks at the check! (Riders return to the same out vet check each time.)

For the 50s: Mileage is accurate and the trail is considered a moderate level course in its difficulty. However, it is plenty doable in the time allotted. Over the last few years, we have not had a 50 mile rider over time on this ride!

For the 35s: In order to take our riders off the hard-packed rutted road that everyone complained about, we had to add a little mileage to our LD, changing it from a 30 to a 35. However, due to the soft footing and gradual climb of the new trail we incorporated, the LD can be ridden faster than the previous one!

New for 2023: We are hosting an ELEVATOR ride this year! The first loop for the 35s and 50s into the out vet check will be the same this year. At this vet check, 35s can elevator up to the 50 if they wish. The second loop for the 50 mile course is new and takes riders up to the Historic InSkip Pioneer Cemetery. The last loop back to camp for the 35s and 50s is the same as it was in previous years.

FUN RIDERS: The Fun Ride is approximately 10 miles long & is a great course for those wanting to just go out and ride some new trail without having the pressure of a longer distance or a timed course. Fun riders pay \$40 & do not need to be AERC members. Fun ride fee includes marked trail, a participation award, and dinner on Saturday night.

THE CAUSE: This ride is for a remarkable cause, in memory of a fine young equestrian who aspired to help and heal others. Kristina Chesterman lost her life in 2013 when she was hit by a drunk driver while riding her bike home from the Chico State library after studying. She was a nursing student who planned to work for Doctors Without Borders. Since her passing, she has given life to others through the gift of her organs and a medical clinic in Nigeria has been opened in her name. Profit from Saturday's ride will go towards the operating costs of that clinic. You will see many of Kristina's friends and family volunteering at this event, carrying on the work she so desired to do.

VETS: We have Anne Williams, DVM, as our head vet this year. She has been part of our vet staff in previous years, and we are pleased to have her as our Control Judge this year! Natalie Sundstrom, DVM, and Robert Gregory, DVM, will also be assisting.

DIRECTIONS:

From the **5N**: Take 99N towards Yuba City/Marysville, then merge onto the 70 towards Marysville. Follow signs through Marysville to continue following the 70 towards Oroville/Paradise/Quincy. From the 70, turn left at the 191/Clark Road towards Paradise. Take Clark until it dead ends at Skyway (approximately 15 miles), make a slight right at Skyway and continue up Skyway for several miles, crossing the bridge and passing through downtown Magalia. You will see Meadowbrook Ranch on your right.

From the **5S**: Take the CA-36/CA-99/Antelope Blvd exit towards Red Bluff/Chico. Follow the 99S towards Chico for approximately 40 miles, then take the Skyway exit towards Paradise (turning left). Follow Skyway through the town of Paradise and then over the bridge into Magalia, proceeding to Meadowbrook Ranch, which will be on the right hand side.
